JUDICIAL SERVICE AS A CAREER – ONE YEAR TRAINING PROGRAMME

BARTI has taken up a pilot project of free and quality coaching to the **Scheduled Caste & Scheduled Tribe (SC & ST)** candidates, so as to enable them to come at par with the open candidates and compete for Judicial Services through competitive examinations.

Bar Council of Maharashtra & Goa (hereinafter referred to as '**Council**') has undertaken One Year Training Program, for fresh Law Graduates and young lawyers up to 7 years of Practice, named “**Judicial Service as a Career**”, to promote and prepare the fresh Law Graduate and young lawyers for their participation in Judicial Services. The Council has accepted in principle, to **include 30 SC candidates in each revenue division (Total 180) and Total 75 ST candidates** in the above said Training Program.

BARTI appeals to all SC & ST Lawyers (from fresh Graduates of Law up-to 7 years of Practice), of Maharashtra State to appear for oral interview on the following places on 10.04.2016 at 10.00 am to 5.00 pm along with Identity card given by Bar Council :-

- **For Nashik Division** at IT Library Hall, District Court Bar Association – Nashik
- **For entire Marathwada Division** at Bar Council of Maharashtra & Goa Office, Room No.22, High Court premises, Aurangabad
- **For entire Vidharbha Division** at Gunvantrao Deshmukh Shikshan Sankul, Pusud, District Yavatmal.
- **For Pune & Kokan Division** at Bar Council of Mah. & Goa , 2nd Floor, PWD Bldg., High Court, Fort, Mumbai.

Salient features

- The entire cost of training of the SC & ST candidates, selected by the Council will be endorsed by BARTI.
- BARTI will bear the cost of the selected candidates' training and travelling expenses up to Rs.2,000/- pm per candidate, through the Council.
