About BARTI

Dr. Babasaheb Ambedkar Research & Training Institute (BARTI), Pune is an autonomous Institute of Govt. of Maharashtra, under the Department of Social Justice and Special Assistance. The institute was established in the year 1978 under the name "Dr. Babasaheb Ambedkar Samata Vichar Peeth" and subsequently became autonomous under its present name in the year 2008.

BARTI is committed for the cause of Equity, Social justice, Brotherhood, Removal of Caste bias, Developing Scientific Temperament and Ethics and Moral Values and achieving progress in these areas through scientific research.

DR. BABASAHEB AMBEDKAR NATIONAL RESEARCH FELLOWSHIP, (BANRF)

INTRODUCTION

In 1913, Dr. Babasaheb Ambedkar undertook a historic journey to Columbia University, New York for Higher Studies. In grateful commemoration of this, BARTI launched "**Dr. Babasaheb Ambedkar National Research Fellowship (BANRF)**" in 2013. Only Scheduled Castes (SC) candidates belonging to Maharashtra, who wish to pursue regular and fulltime M. Phil. and Ph.D. in any subject from Indian Universities / Institutions / Colleges approved under UGC are liable to get fellowship.

Year 2014 marked 101 years of Dr. Babasaheb Ambedkar's historical journey to Columbia. In commemoration of this, One Hundred and One (101) M.Phil. / Ph.D. fellowships were awarded in the year 2014. The number of fellowships awarded each year would be equivalent to the number of years since 1913 i.e. 101 for 2014, 102 for 2015 and so on. BARTI is keen to support the candidates with academic excellence and methodologically sound research projects pertaining to social justice, equity, humanities, Social Sciences, Sciences, Engineering & Technology and related field.

OBJECTIVE

 To provide fellowships in the form of financial assistance to the students belonging to SC category & domicile of Maharashtra State to pursue higher studies such as M.Phil.
 & Ph.D. (full-time) in Indian Universities /Institutions / Colleges approved by UGC.

ELIGIBILITY

- Applicant must belong to Scheduled Caste Category & domicile of Maharashtra State, who has passed the Post- Graduation examination in any discipline/Subject/Branch.
- Applicant applying for BANRF 2018 must be registered for M. Phil./ Ph.D. in Indian Universities / Institutions / Colleges approved under UGC only. <u>Not Registered</u> <u>applicants are not eligible to apply BANRF 2018.</u>
- 3. <u>Applicant applying for BANRF 2018 must have their M.Phil. /Ph.D. Admission/</u> <u>Registration date on or after 20th July 2017 to 10th December 2018 or Last date of</u> <u>Online Application Submission date of BANRF 2018.</u>
- Age of applicant should not exceed more than 40 years as on the 10th December
 2018 or last date of online application submission date.
- All-inclusive family Annual Income of the applicants should not be more than INR
 6 lakhs.

RESERVATIONS:

- 1. 50% of fellowships reserved for SC Female candidates.
- 2. 3% of fellowships reserved for SC Candidates with disability. Disability % should be more than 40 %.

INTEGRATED M.PHIL. / PH.D. PROGRAMME.

BARTI does not conduct integrated M.Phil. / Ph.D. programme (2+3 years). In case, the selected candidate is pursuing an integrated M.Phil. / Ph.D. programme (2+3 years), selection for M.Phil. does not imply selection for Ph.D. fellowship automatically. Applicant has to apply for Ph.D. Fellowship through a separate application after completion of M.Phil.

TENURE OF FINANCIAL ASSISTANCE

FOR M. PHIL -

 The tenure of fellowship for M.Phil. will be minimum 1 year to maximum 2 years as per the academic tenure specified by concerned University which will be considered from the date of Registration/Admission. No further extension will be entertained.

2. <u>The actual fellowship benefits will be disbursed from the date of</u> <u>Registration/Admission, till the completion of academic tenure specified by concerned</u> <u>University or the date of thesis submission, whichever is earlier.</u>

- 3. In case candidate fails to complete M.Phil. within stipulated time period and gets extension from the concerned University, BARTI will not disburse any financial benefits in extension period.
- 4. In case there is duration gap in between Registration date & Actual joining date to University/Research Centre due to any reason then candidate has to furnish a gap certificate from a competent authority of the University/Research Centre stating the reasons for the gap taken. <u>BARTI will not be liable to disburse any fellowship/HRA/Contingency/etc. amount during gap period.</u>

FOR PH.D.-

Dr. Babasaheb Ambedkar National Junior Research Fellowship (BANJRF) for 1st & 2nd year and Dr. Babasaheb Ambedkar National Senior Research Fellowship (BANSRF) for 3rd year of Ph.D.

- The tenure of fellowship for Ph.D. is 3 years which will be considered from date of Registration to respective University.
- 2. <u>The actual fellowship benefits will be disbursed from the date of Registration to</u> respective University to till the completion of 3 years or the date of thesis submission, whichever is earlier.
- In case candidate fails to complete Ph.D. within stipulated time period and gets extension from concerned University, BARTI will not disburse any financial benefits in extension period.
- 4. In case there is duration gap in between Registration date & Actual joining date to University due to any reason then candidate has to furnish a gap certificate from a competent authority of the University stating the reasons for the gap taken. <u>BARTI will</u> <u>not be liable to disburse any fellowship/HRA/Contingency/etc. amount during gap</u> <u>period.</u>
- 5. **Up-gradation from JRF to SRF** On completion of 2 years from Registration to Ph.D., fellow has to go through Research progress evaluation, for which a three-member committee shall be constituted by the concerned department of University/Institution/College

comprising of Supervisor, Head of the department & one outside Subject expert. The Awardee should give detailed presentation about his/her topic to the committee. The recommendations of the committee shall be submitted to the BARTI for up gradation to the level of BANSRF.

- a. SRF up-gradation process should be completed within 2 months after the completion of JRF period i.e. two years from date of Registration.
- b. In case, the said tenure exceeds more than 2 months, SRF up-gradation will be considered from the date of meeting of Three Member Committee, hence, fellowship related monetary benefits with higher rate i.e. Rs 28,000/- per month will be disbursed from the date of meeting of Three Member Committee onwards, for the remaining tenure of the third year.
- c. In case Awardee fails or delays to submit SRF up-gradation certificate & Three Members Committee Report within stipulated time period, he/she has to furnish a letter from a competent authority of the concerned University stating the reason for the delay or non-submission.
- d. No further benefits will be released unless & until Awardee submits SRF up-gradation certificate & three Members Committee Report to the BARTI.

RELEASE OF LAST INSTALLMENT:

The last 6 months Installment will be released only after the submission of research thesis & Completion Certificate to BARTI.

1. Additional "6 months" period (without fellowship benefits) will be given for thesis submission after completion of academic tenure of the concerned University for

M.Phil. candidates, failing which the last '6 months' fellowship amount (Payable Amount Stage VI, VII & VIII) will not be disbursed.

- Additional "2 Years" period (without fellowship benefits) will be given for thesis submission after completion of 3 years for Ph.D. candidates, failing which the last '6 months' fellowship amount (Payable Amount Stage X, XI, XII) will not be disbursed.
- 3. In case candidate fails in final exam of M.Phil. / Ph.D. in his/her first attempt, fellow will not be liable to get last 6 months' fellowship amount, last year HRA & Contingency Amount. But the fellow will have to submit the research thesis whenever he/she passes the final exam of M phil./ Ph.D.

FORMAT TO CLAIM BENEFITS UNDER BANRF-2018 FELLOWSHIP.

1. Joining Certificate: - Annexure –I (A)

Awardee shall submit Joining Report in the prescribed format along with the set of all the required documents to the BARTI office to avail benefits under BANRF-2018 fellowship.

2. Joining Certificate: - Annexure – I (B)

In case awardee holding a job during the period from Date of registration to Date of Award, Awardee shall submit Joining Report - I (B) in the prescribed format separately along with Resignation letter/ Relieving letter / Experience certificate etc.

3. Half Yearly Progress Report- Annexure -II

Awardee shall submit Half Yearly Progress Report on completion of 6 months from the date of registration and at the interval of every 6 months till the completion of fellowship tenure.

4. House Rent Allowance (HRA) - Annexure - III

Awardee shall submit House Rent Allowance certificate on completion of 1 year from the date of registration and at the interval of every 1 year till the completion of fellowship tenure along with Non-Hosteller Certificate or Hostel Bill Receipts paid by Awardee in given Performa.

5. Utilization Certificate for Contingency Amount - Annexure -IV

Awardee shall submit account of Contingency certificate on completion of 1 year from the date of registration and at the interval of every 1 year till the completion of fellowship tenure.

6. Up-gradation Certificate- Annexure V

Awardee shall submit Up-gradation certificate on completion of 2 years from the date of registration to Ph.D. along with Three Member Committee Evaluation Report.

Monthly Attendance sheet certified by Supervisor/Guide, to be submitted for the period mentioned in the Half Yearly Progress Report.

Awardee shall submit personal bank account details after final selection for BANRF - 2018.

BARTI may verify the genuineness of records & ask additional / revised documents if required at any stage.

MEDICAL

No separate /fixed medical assistance is provided. However, the fellow may avail of the medical facilities available in the University/Institution/College.

SELECTION PROCEDURE - BANRF -2018

Candidates are filtered at every stage through below mentioned elimination process.

Stage -I SCRUTINY & SHORT LISTING

- ✓ Online application will be invited for BANRF 2018 fellowship.
- Applicants have to submit online application & upload all the necessary documents online, which will be scrutinized by BARTI.
- ✓ After scrutiny, Merit list of total valid applicants will be prepared for further process.



Stage -II PREPARING MERIT LIST

- Merit list will be prepared by giving 25% weightage for marks obtained in Graduation and 75% weightage for marks obtained in Post-graduation.
- ✓ 420 applicants who have secured highest marks in merit list will be shortlisted for 105 fellowship seats as per 1:4 ratios.

✓ These 420 qualified applicants with highest marks will be called for next level of selection process i.e. written test.

Phase -III

WRITTEN TEST

Written test & Original Document verification will be conducted for 420 qualified applicants.

- ✓ Original Document Verification Process
- ✓ Written test will consist of 50 objective type multiple choice questions, each question will have four options, from which applicant have to choose right one.
- ✓ Each question will carry 1 mark.
- ✓ Negative marking will not be applicable.
- ✓ 30 minutes will be given to solve question paper.
- ✓ Question will be designed based on Social awareness, Social thinkers, Research methodology, logical reasoning, statistics, general knowledge, aptitude.



Phase -IV INTERVIEW

Candidates appeared for the written test will be called for next level of selection process i.e. Personal Interview. Interview will be conducted based on following 5 points. Each point will carry 10 marks out of total 50 marks


- 1. Proposal writing 10 Marks
- 2.Literature Review 10 Marks
- 3. Understanding/Knowledge of proposed research subject 10 Marks
- 4. Research methodology & Presentation 10 Marks
- 5.Communication skills 10 Marks
- ✓ Candidate Absent in interview & written test will be debarred from further selection process. No request will be entertained.

- ✓ The objective of the personal interview is to check suitability of the candidate for fellowship & to judge the mental calibre of candidate.
- ✓ Marks thus obtained by the candidates (in the written & interview) would determine their final selection



RECOMMENDATION OF APPLICANTS FOR SELECTION UNDER BANRF-2018

Merit List will be prepared as per reservation criteria based on highest marks obtained (out of 100 marks) in Written test and Interview.

FINAL SELECTION

Final Selection of the recommended 105 applicants will be subject to passing original document verification process.

CANCELLATION OF AWARD:

Fellowship awarded is liable to be cancelled, in case of:

- 1. Misconduct
- 2. Submitting fake documents/ Information
- 3. Candidate is already availing scholarship/fellowship from any other sources.

- 4. Candidate if found employed during the M.Phil. /Ph.D. research. & not informed to BARTI
- 5. Candidate is later found ineligible.
- 6. Unsatisfactory progress of research work.
- 7. Not doing full time M. Phil /Ph.D.
- 8. Leaving M.Phil. / Ph.D. in between due to any reason.
- 9. Any false information furnished by the applicant or any fraudulent activity by the Scholar/Fellow/Research Awardees.
- 10. If it is found that candidate has already availed fellowship benefits from other institute/university/RGNF, fellowship will be cancelled with immediate effect and legal action will be proceeded against him/her for deceiving BARTI.

OTHER CONDITIONS:

- The selected fellow will have to undertake full-time research work under the approved guide in a subject selected by him/her and approved by the University/selection committee.
- 2. Research topic chosen for M.Phil. / Ph.D. can be modified but cannot be changed totally during the tenure of availing BANRF. In case, the fellow is willing to change the topic he/she shall intimate BARTI regarding this. The decision about continuation of the fellowship will be taken by DG, BARTI, which will be binding on candidates.
- 3. Any change in Fellow's funding status should be brought to BARTI's notice immediately. The fellow is not allowed to accept or hold any paid appointment, full time, part time, or receive emoluments, salary, stipend, fellowship, business etc. from any other source during the tenure of the award <u>subject to verification</u>. In case of breach of above conditions, BARTI will discontinue his /her funding without any notice. The fellowship, HRA, Contingency and any other benefit paid previously, will be liable to be recovered.
- 4. If the fellow wishes to surrender the fellowship during the tenure or discontinues M.Phil./ Ph.D. course in between due to any reasons, it should be brought to BARTI's notice in writing within 15 days of such discontinuation. However, fellow will have to

pay back the Fellowship, HRA, Contingency amount, Escorts/ Reader assistance amount (if taken) and any other benefit given to fellow under BANRF to BARTI.

- 5. Fellowship may be withdrawn if the progress is not considered satisfactory or the candidate fails in any of the examination related to M.Phil./ Ph.D.
- 6. The fellow may assist the departments academic activities, including tutorials, evaluation of test papers, laboratory demonstration work, seminar symposia etc., provided the candidate has the consent of the guide / Head of department and such engagement is not likely to hamper his/her research work.
- The candidate will have to be present for events organised by BARTI like conferences, Workshops, Presentations, meeting and any other occasions or inquiry during the fellowship tenure for which, No T.A./D.A. will be provided.
- 8. Candidate shall furnish affidavit stating that he or she will complete M.Phil. / Ph.D. in academic tenure of concerned university. In case of extension of the above period he or she shall submit Extension certificate from competent Authority to Barti for further information.
- 9. Director General, BARTI reserves the right to relax income limit & age limit or any other condition in exceptional case only.
- 10. BARTI may add additional terms and conditions as and when required which will be binding on the Fellows.
- 11. In case of any dispute arises regarding BANRF, the decision of Director General, BARTI will be final which will be binding on the Fellows.
